### Step-I:

- i) Deposition of requisite amount of **Earnest Money, ₹ 1,50,000/- (Rupees. One Lac. Fifty Thousand only)**.
- ii) **The party should submit the Bid Quantity in MT/month as attached in annexure-A 1.**
- iii) Minimum quoted quantity should be **5000 MT/month**.

\* **Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.**

### Step-II:

Qualification bid: Submission of documents as per following qualification requirements:

- i) PAN No., Current Income Tax return, applicable Tax (Professional Tax and GST Registration Certificate, ARN No.), Provident Fund (P.F.) Registration Certificate.
- ii) Audited balance sheet for last three financial years (**2014-15, 2015-16, 2016-17**) to satisfy the following criteria:
  - a) Average annual turnover in the last three financial years should be more than 30% of (**Quoted quantity per month × reserve price × 12**).
  - b) Net worth of the **last three financial years ending in FY 2016-17** should be positive.

- iii) An undertaking in non-judicial stamp paper / company's letter head to be submitted by the bidders  
i.r.o. adequate no. of Bulklers /Browsers/ Closed containers having proper registration under Motor Vehicle's act, to be used for dry fly ash transportation to and from the silos of the concerned plant.
- iv) The bidder shall submit the certificate of successful completion of lifting dry fly ash from silos with Bulklers /Browsers/ closed containers for 80% or more of the quoted annual quantity under annual contract with Thermal Power Plants. The aforesaid certificate of lifting dry fly ash from the power plant should be issued by the concerned plant official , mentioning the quantity of annual drawal of fly ash by the bidder with help of Bulklers /Browsers/ Closed containers and allotment order.
- v) The bidders, whoever lifted dry fly ash from any of the power stations of WBPDCCL shall have to submit 'no dues certificate' issued by the concerned plant authority; otherwise their bid will not be considered.
- vi) In case the bidder has not lifted dry fly ash from any of the power stations of WBPDCCL, he has to submit an undertaking to that effect.

## Step-III:

### Techno-Commercial Bid:

All the pages of tender document including all the documents (except particularly mentioned document ) to be submitted by bidder shall be duly signed / authenticated and stamped in acceptance of Techno-Commercial Terms and Conditions.

## Step-IV:

### Price Bid (To be submitted as per annexure A2)

Bid documents can be obtained from Purchase dept. on the basis of written application to Sr.Manager (S&P), BKTPS, WBPDCCL, during working days on submission of cash/DD only.

- a) Tenders must deposit earnest money by Demand Draft / Banker's Cheque in favour of 'The West Bengal Power Development Corporation Limited' drawn on any Nationalized or Scheduled Bank. Suri / BkTPP in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No Interest shall be paid against the earnest money.
