Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- 1. a) Valid PAN, IT return of last year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
 - b) Audited balance sheet to satisfy the **net worth** (for the year **2011–2012**) of the intending party **not less than Rs.20 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
 - c) The bidder should be well experienced in executing similar type of contract having order value of at least **Rs. 26 lakhs per annum** within a period of last five years.
- 2. a) The party must have minimum two(02) years' experience in online stone picking job from running conveyor belts at CHP in a thermal power plant of at least 210MW capacity.

Step-IV: Price Bid.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money. No tender will be entertained without earnest money.
