Description of the Work: Annual Contract for Operation & Maintenance of ESP and entire Ash Handling Plant and Coal Mill Rejection system for 250 MW Unit no. 5 & 6 under AHP dept., STPS **as per 'Scope of Work' and 'Terms & Conditions' as stipulated in this Tender Documents.**

<u>INFORMATION TO BIDDERS</u>: This is a Four Part bidding system containing Earnest Money (Part-I), Qualifying Requirement (Part-II), Techno-Commercial (Part-III) and Price Bid (Part-IV). The same will be received and evaluated by the WBPDCL, STPS from Technical and Financial point of view to make a selection in the best interest of the WBPDCL, STPS for the complete work covered under the tender document.

1) Earnest Money: The Earnest Money of □ 6,00,000.00 (Rupees Six Lac Only) shall be deposited along with tender papers in the form of Bank Draft / Pay Order issued by any reputed Banks (preferably Nationalized Banks) from India in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at Santaldih, Purulia or Kolkata Branch.

2) Contract Period: Two Year.

3) Estimated value : \Box .6.0 Crore

4) Cost of Tender Paper: \Box . 5,000.00 (Rupees five thousand only).

5) Eligible Criteria:

A). Must have experience as follows:-

- **A1.** The tenderer should be a regular manufacturer, constructor and turnkey supplier of ash handling plant of vacuum and pressure combined ash handling system in a thermal power plant of minimum plant capacity of 210MW.
- **A2.** The tenderer should have experience of Operation & Maintenance contract for a minimum period of 2(two) years or higher executed during the period of last 5(five) years for similar nature of plant i.e. vacuum and pressure combined ash handling system for fly ash and bottom ash removal through clinker grinder with hydro ejector in a thermal power plant of minimum plant capacity of 2x210MW.
- **A3.** The Tenderer shall furnish necessary experience certificates / Work order in support of their past experience, as above.
- **A4**. The tenderer should have a requisite infrastructure to provide design, engineering, erection and commissioning support that may be required for smooth and efficient functioning of O&M activities of the ash handling plant.
- **A5.** One similar work order amounting to Rs. 1,50,00,000/- per year or more in a single order in case of serial no. 5A2.
- **B). Must be financially strong**: Audited balance sheet with profit & loss account for the last three years and Bank statement are to be submitted along with tender documents in Part II i.e. Qualifying Requirements.
- C). Must be technically capable to do the same type job for 250 MW Units or higher capacity. Must be a regular manufacturer, constructor and turnkey supplier of ash handling plant of vacuum and pressure combined ash handling system in a thermal power plant of minimum plant capacity of 210MW with a requisite infrastructure to provide design, engineering, erection and commissioning support.

6) <u>Sale of Tender Paper</u>: From dt.01.01.2013 to 07.01.2013 on all working days up to 15=00 hour except on Saturday upto 12=00 Hours. Sale of tender paper to the applicant will not qualify them automatically in Techno-Commercial bid. Tender paper will be sold to each of the applicants. Necessary documents are to be submitted as per list given below:

(3) Credentials of executing the job of Operation & Maintenance of Ash Handling Plant, ESP and Mill Reject System for the Unit of 210 MW or above for at least 2 (Two) years out of last five years i.e. at least 2 (Two) years Experience Certificate / Copies of Work Orders in executing similar job of adequate order value not less than □. 1,50,00,000/- per year in a single order, executed / being executed for at least 2 (Two) years out of Five preceding years for which completion certificate or work order with schedule is to be submitted.

The WBPDCL reserves the right to cancel the quotation in absence of the above documents at their discretion.

- 6.1 : The WBPDCL reserves the right to cancel / accept the tender in absence of the documents at their discretion in case competent authority deems it.
- 6.2 : Legible photocopies of all documents are to be submitted with counter signed by tenderer. Original copies of documents are to be produced on demand.
- 6.3: The tender, Qualification of bidder (Part-II) shall contain the name, Residential Address, Phone Number, Fax Number of person(s) authorized to sign the tender for future contact.
- 6.4 : Capability of making Labour Payment within 10'Th of every month without looking forward for release of bill from F&A Dept., STPS.
- 6.5 : Capability to control the labours with sufficient command and confidence.
- 7) <u>Pre-Bid Discussion</u>: It is intended to have a site visit & pre-bid discussion at the Office of Sr. Manager(M&C), STPS on dt. 11.01.2013 at 15=00 Hrs. to provide any additional information and furnish clarification, if any, needed on the scope of work and tender documents. Any modification or addenda to tender documents resolved shall also be part of these tender documents. Parties not attending the pre-bid discussion are also liable to abide by the output of pre-bid discussion.

Special Note:

So far the improvisation of the subject work is concerned, which is beneficial to WBDPCL, WBPDCL reserve the right to alter any term or condition or technical details prior to submission of bid. In that case the same will be intimated in black & white to all the parties, brought the tender paper.

- 8) <u>Last date of Submission of Complete Tenders and opening of Part I & II of the Bids</u>: 17.01.2013 up to 15=00 Hrs. and 15=15 Hrs. respectively.
- 9) Opening of Tender:
- 9.1: The tenders shall be opened in presence of representative of the tenderers at the time of date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the tenderers who have purchased the tender documents. Tenderers' authorized representative (upto two persons) may attend the opening.
- 9.2: The due date and time of opening of E.M.D. & Qualifying Requirement of bidder is after 15=15 Hrs. on 17.01.2013. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.

- 9.3 : Techno Commercial (Part-III) of tender of those tenderers who will be considered qualified in view of Part-I and Part-II by the WBPDCL, shall be opened subsequently on dt.17.01.2013 or at a later date. The due date and time for opening of Techno Commercial part shall be duly intimated.
- 9.4 : Price Bid (Part-IV) of tender of those tenderers who will satisfy qualifying requirements and who will accept technical and commercial terms & conditions of this tender shall be opened subsequently on dt.17.01.2013 or at a later date. The due date & time of opening of price bid will be duly intimated.

10) Evaluation of Tender:

- 10.1 : Issuance of tender documents will not mean that such tenderers are automatically considered qualified for the entire tender process.
- 10.2: The WBPDCL reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDCL shall not be subject to question by any tenderer and the WBPDCL shall bear no liability consequent upon such decision and the tenderer shall have no claim in this regard against the WBPDCL.
- 10.3 : Evaluation by the WBPDCL shall be based on the information and documentary evidence submitted by the tenderer in response to the tender documents. The requirements as stipulated in the tender notice and documents are the minimum and the WBPDCL has the right to request for additional information. The WBPDCL reserves its right to reject any tender, if in the opinion of the WBPDCL the qualification data / documentary evidence submitted by the tenderer is incomplete or tenderer is found not qualified to satisfactorily perform the work. The WBPDCL reserve the right to reject any tender if the tenderer is found to be disqualified by giving incorrect and / or false information.
- 10.4: The WBPDCL does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one tenderer and also reserves the right to reject any or all tender or cancel the tender without assigning any reason whatsoever.
- 10.5 : Notwithstanding, anything stated above or elsewhere, the WBPDCL reserves the right to asses the capability and capacity of the tenderer, should the circumstances warrant such assessment in the overall interest of the WBPDCL.
