 - b) Audited balance sheet to satisfy the **net worth** (for the year 2010-2011 or 2011-2012) of the intending party **not less than Rs. 2 lakhs 50 thousand** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. The bidder should have at least one order on any structural job within a period of last three years.
