- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the **net worth** (for the year **2011–2012**) of the intending party **not less than Rs. 6 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- a) The bidder should be well experienced in executing similar type of contract having order value at least **Rs. 8 lakhs per annum** within a period of last three years.
